Key Findings 2022

Executive Summary

- TMT: Tech has been removed, resulting in distribution of firms and individuals the M&A, Startups and Privacy and Data Protection tables. In conjunction, these practices saw the most changes 32%.
- Expansion of the four new sub-tables, introduced in 2021, for individuals (individuals ranked were derived from main table): Banking: regulation, Employment: Employee & Trade and M&A: Fund formation. Addition of new Arbitration and Mediation sub-table).
- 18 law firms showed improvement (up or new entry) in the 2022 rankings, by practice (compared to 25 in 2021).
- 46 law firms showed improvement (up or new entry) in the 2022 individual rankings (compared to 29 in 2021).


Executive Summary

- 171 changes in the individual rankings. More than 2021+2020 combined.
- 60 changes in the practice rankings. Slightly higher, but still consistent, with the previous years.
- In the 20 categories researched, 19 firms moved down (compared to 6 in 2021) and 46 lawyers moved down or out (compared to 24 in 2021).
- In 2022 we notice 12 movements up in the practice rankings the lowest in past 4 years).
- 3 law firms managed to climb to Band 1 (each one twice!) and 11 individuals succeeded to climb to Band 1 (compared to 3 in 2021).


Executive Summary


- Only 18 Israeli law firms improved their rankings in 2022 (up or new) and 19 law firms in total went down or out of the rankings.
- Among the top-20 law firms (by size), only 60% improved their rankings, 30% moved down/out and 25% saw no change at all.
- Six boutique/niche law firms improved their rankings and nine went down or out of the rankings.

Total number of changes - practices

















Graph Explained

Most ranked Individuals




