# **Key Findings**

## **Executive Summary 2024**

- In 2024 there are more changes in the rankings than in the past two years combined. Although 133 is a high number, it is lower than the number of total changes in 2020 (134 changes), 2019 (175 changes) and 2018 (138 changes.
- For the past three straight years, we saw more movement down than up in the practice tables. This year we counted nearly 3 times more improvements (up and new).
- Unlike in 2023, where most of the focus was on "next generation" and "rising stars", this year most of the focus in the individual rankings table was in the leading individuals.
- 104 lawyers entered the individual rankings (leading/next generation/rising stars), similar to 2023 (108 lawyers entered). However, many have found themselves out - 28 lawyers have been pushed out (similar to 2023 - 24 lawyers). Interestingly, this amounts to the sum of the past 5 years combined (2018-2022).

# **Executive Summary**

- Seven law firms moved up to Tier-1.
- 26 lawyers moved up in the individual rankings (from next generation to leading or from associates to watch to next generation). This is 3 times more than in 2023 (12).
- Practice with the most negative improvements healthcare (6 firms went down, due to the introduction of Tier 3).
- Practices with the most improvements are tax (8), M&A (8), IP:Disputes (7) and employment (7).
- Practices with the most new lawyers to enter the rankings: Hi-Tech (15), Dispute Resolution (10) and Class Actions (9).

## **Executive Summary**

Additional Stats:

- average number of moves up in the rankings, per firm 1.2 (as opposed to 0.75 in 2023, to 0.6 in 2022 and 1.5 in 2021) and average of going down 0.5.
- average of new individuals in the rankings, per firm, is 1.4 (in comparison to 2.6 in 2023 and 2.2 in 2022).
- 53 law firms improved their practice rankings and 34 firms improved their individual's rankings. only 8 law firms have more than 5 new individuals in the rankings.
